NGOs & Partners in PLAnet, members of the Peoples Organization for their active participation in achieving project goal & objectives as well as all the well-wishers of CDA in different Fora & the Apexes at the national & international levels.

During the reporting period of July 2010 to June 2011. CDA interventions were to empower the rural land less poor people through the concept of village based Peoples Organization (PO) to access local public resources with a view to ensure food security and poverty reduction of the North-West part of Bangladesh. As CDA has been facilitating to implement a project namely "Sustainable Organization for Land Rights and Agrarian Reform (SOLAR)" in partnership with Bread for the World, Germany from May 2010 to July 2011 to its Goal: Ensure access to the local public resources (land/water bodies/Forests) by the local poor in the project areas. The expected result of the project was: Selected Peoples Organizations and local NGOs are strengthened to facilitate the access to local public resources by the local deprived poor; Policy makers and local administration are sensitized to support pro-poor land related polices and the formation of an independent land commission to ensure land right of the Ethnic minorities and women; Community people are aware about HIV/AIDS and violence against women and organized for protection and behavioral change of the people; An appropriate level of institutional capacity for the project implementation is maintained. During rally and day celebration in different events women's participation was higher than the men (about 70%), Women were able to voice their rights and submitted memorandum to local Administration and local Government leaders demanding on equal rights.

The project achievements are: 17 Land less Women received agricultural land legally: 2 Widows received Agricultural Land from Local Authority through this project support; 207 Widows are getting Widow Allowance from local Government through pressurization of the members from the Peoples Organization (PO); Total 177 Number of families are having access to 30.9 acres of local public land; 233 Families are having access to 50.09 acres of local public water bodies; 1135 Numbers of families are already benefited from this project. It is observed and discussed with the families who received land or having access to water bodies through this project support they are getting more meals comparing the time of preproject implementation, as well as they determined their own strategy to fight against the crisis (food scarcity) i.e. harvesting fish during Monga (a seasonal economic recession) from the public ponds, PO based savings (total savings amount of Tk. 1,184,24.00); 177 Land less Farmers received 30.9 acres of Khas land by which their income has been increased; also the targeted POs initiated project on Cow/Goat rearing, Credit support among the members from PO savings accounts.

During December 2010 CDA completed its Pilot Project successfully as named Junior School Certificate (JSC) Course in Partnership with CAMPE and Bangladesh Open University, in 4 Open Distance Learning (ODL) Centers. Average student attendance in different classes were 82% and 100% students succeeded the courses according to schedule.

Major Achievements during July 2010 to June 2011 in CDA's Micro finance program as provided loan support about 85,74,653.00 taka among 4,902 borrowers, where net savings amounting to 33,01,846.00 taka and Savings refunded amounting to Tk. 2,14,644.00 among 1,223 Members.

About 5651 copies of Jono Chesta were published and distributed among CDA's POs / Samity Members and to the different levels of stakeholders during the period.


2. Preface: 9 9 9

Community Development Association (CDA) has been working in the North-West of Bangladesh since 1986. It was founded with the strategic aim of poverty reduction and people's empowerment. Through continuous experimentation and learning, CDA has arrived at its current days with a methodology of facilitating the capacity building to its poor people's institutions as a long term sustainable development support mechanism.

Despite subtle changes over the years, the fundamental principles followed by CDA's vision remaining the same as those for which the organization is established.

CDA's vision is a society united through its people centered democracy by good governance which is socially just and free from all forms of discrimination. Human rights will be established and the community will be economically productive within an ecologically balanced environment.

CDA has integrated programs in 8 Upazilla under two districts Dinajpur & Thakurgaon in the North-West of Bangladesh. There are almost 60,000 members in IB program as a core in 6 Upazilla and an additional 6,000 members within its credit & savings program in another 2 Upazilla.



In fact, CDA is a programmatic organization although it has a number of small projects is operated with innovations until changing the social context. There are 6 programs within CDA's intervention areas are operated simultaneously through the core program IB. Therefore, in the entire CDA's working areas under the IB the POs have the access to the

same activities following the same principles in regards to their own development. Of course, each PO has its different needs upon its analytical context and it has its reflection in annual planning process with a flexible manner.

The aim of CDA's Institution Building (IB) program is to empower the poor and marginalized people to achieve their rights. One of the most specific objectives to create strong Peoples Organization through providing capacity building support. So it can act as village based institutions for self help development and promoting local governance.

Institution Building is a core program and being a foundation on which the other five program components are accelerated. It is a people centered mechanism constituting step by step through building groups are called samities at Para level then Peoples Organizations (PO's) at the village level are formed with at least four groups / samities and then village based People's Organization (PO) are federated widely with a political view at the constituency level voicing their pro-poor policy recommendations by the respective member of parliament. It is also a mechanism through which people ensure linkages & partnerships to build up the capacity of leading towards social transformation as well.

Besides, the Institution Building efforts is a socio-political process instituted by the poor in association with the local civil society parallel to the local Government tier to bargain to have access and control, to protect and protest against the bad Governance, such as against the corruption and crimes, terrorism, fundamentalism, partisan-nepotism and to mediate the domestic violence against the women and ethnic minorities.

Employment Creation through Fish Culture:

Amgaon Peoples Organization is at Amgaon village in Horipur Upazila under Thakurgaon District is established with 235 members. The president of Amgaon PO both Mr. Azmul Haque and Treasurer Md. Delowar Hossain arranged a training course on Fish Culture with the Department of Fisheries. 72 numbers of men and women attended the month long training course. After receiving the course the trained members introduce fish culture individually and collectively at their villages The PO has taken lease a pond for ten years measuring the area of 5.00 from their own fund. Every year the PO earns Tk. 1,36,570.00 from such initiative where 4 PO members are employed permanently and each PO members are receiving fish for family level consumption.

Furthermore the PO has started a plantation scheme by taking lease of 5 acres of land where the PO members planted about 4000 Neem tree plants. The PO Members expected that they will earn about 400,000/- taka from the plantation scheme.

There are 135 PO members are in Amgaon PO. It is situated at Amgaon village of Amgaon union under Horipur Upazila of Thakurgaon district. The president of Amgaon PO stated that through PO, now we could dream to earn and fight against unemployment within the villages.

Member of Parliament provided interest Free loan among the victims of Disaster.

I am the President of Dhoula Peoples Organization and Union Coordination Committee (UCC) of Gedura. On 16th February 2011 at 4:00 O-clock a storm with hail attacked to Horipur Upazila. 4 Unions were badly affected by the storm. In Gedura Union crops of 4000 Acres of land were completely damaged within 20 minutes. UCC leaders and myself visited 11 Peoples Organizations under the Union Parisad and observed that the Wheat, Maize, Potato, Mustered and Paddy crops were laid down on the earth and estimated that the corps of about 40 million taka were damaged. We decided to call on the Member of Parliament to see the practical situation of the victimized peasants and take necessary action to help the poor peasants for quick recovery. The Member of Parliament visited the entire damaged areas of Union Parisad along with Upazila Chair, Upazila vice Chairs, Upazilla Nirbahi Officer (UNO) and Upazila Agriculture Officer. After visiting the place the MP shared in a meeting with the victims of storm. He realized the people's problem and declared to provide Interest Free loan among the victims to recover them.. The peasants received interest free loan through local bank and able to overcome the losses.

Now we think If a People Centered structure such as Dhoula village is establish in each villages of Bangladesh it can be a great support mechanism of the poor people to solve any problems by themselves.

Till December 2010 CDA has completed successfully its Pilot Project namely Junior School Certificate (JSC) Course in Partnership with Campaign for Popular Education (CAMPE) and Bangladesh Open University (BOU), In 4 Open Distance Learning (ODL) Centers in Rajuria High School of Biral Upazilla, Kallyani High School under Kaharol Upazilla, Purbo Mallikpur High School of Kaharol Upazilla, Kobi Nazrul High School of Birgonj Upazilla under Dinajpur District.

Goal of the project:

 to develop skilled manpower through creating opportunity among the dropout students with a minimum cost for poverty reduction and development.

Objectives of the project:

- to create effective educational opportunity for the drop out students from formal and non-formal schools;
- mass awareness (Government and Private Sector) in favor of easy and open system education.

JSC education course allowed me to continue my study as well as to assist my father in his daylong work. I used the products of

I was very much impressed on the educated persons and the way they talk about the overall environment. Therefore, I promised not to discontinue my study by any means attending 2 classes at school.

I think it was a great initiative taken by the Open University and CAMPE, through CDA for the drop out students who are in crisis in their families they can have chance to continue further study along with the opportunity of regular employment side by side. Thanks to CDA to select Purbo Mollikpur School as a center for Junior School Certificate Courses.

Firstly, CDA's health program is to tackle preventable causes of ill health through education and awareness rising. we are able to ensure Land Rights in Our Village among 75 Land Less families.

Charvita village is situated in Bukua Union Parishad in Horipur Uapzila, under Thakurgaon District. The location of the village is closest with the indian boarder and about 14 kilometers away from Upazila Headquarter.In1989 the villagers started to organize Samitties (Small groups), gradually the groups were formed as para based of 4 samities. On 15th July 2002 the para based samities initiated to declare the village based Peoples Organisation (PO) according to the by-laws. After formation of the PO CDA arranged an internalisation workshop on PO concept with 40 male and 40 female members. To strengthen PO and capacity of the members CDA provided training on Organisation Development and management Training, Partnership Development and Management, Leadership and Communication Training, Training on Strategic Planning, Project Management, Office Management, Resource Mobilisational, Human Rights and Good Governance and the most recent training provided on Land Rights and Land Administration in collaboration with ALRD.

After recieving the training the President of Charvita PO, Mr. Nurul Islam convened a General Body meeting of the PO, where 64 members attended. The president dessiminated the idea about the process of accessing khas land which he learned

from the training and he transferred to the PO members that access to khas land is a right to the land less people. According to the decission in the meeting the PO members demarkated the khas land within their village/mouza and identified the landless people at the same time within the village. During the survey the PO members found that about 71% of the total families of the village are land less. Then the PO members decided to submit application to the local land office to have access the khas lands, on prirority basis they submitted 80 nos. of applications in favor of land less families.

The Poeples Organisation is now famous to the other villagers as well as the PO members are very active in identifying khas land, collection of identification number from local land office, communicate with the Union Chairman to get land less certificates and submit application to upazilla land office with the leadership of their president. The PO members also ensured equal participation of men & women in their village development activities and village level arbitrations as a result village level conflicts are reduced.

On June 18, 2011 about 75 nos. of families recieved legal document of 11.25 acres of agricultural khas land from which about 337 nos. of people are benefited including women, children and persons with disability.

The Executive body members initiated advocacy with the local government and able to ensure widow allowance, VGF/VGD cards, old aged allowances for the PO member's families. They also organised discussion with the villagers on early marraige and aganist dowry.

10. Human Resource Development Program , s

Bangladesh has a massive population which is currently a so called burden but it has tremendous potentiality to serve as a human resource. It has been proven by some successful countries that appropriate use of human resources can reduce poverty & economic crisis.

CDA's aims to developing Human Resource as potential. Much of the work is through training and sharing skills both within the organization and outside at the local, national, hence greatly expanding the beneficiaries of this program. Other areas of training in this program include a new focus on technology and a plan to improve communication, management,



leadership and coaching skills among CDA's staff and to the beneficiaries as well

In order to increase the institutional capacity of the POs towards self governance, CDA offers extensive training support. While some initial stage training and workshops were aimed to provide at the entire group members for conceptual awareness, more advanced training was delivered to the Executive Committee members of the groups for strengthening their leadership & capacity.



Training conducted during 2010-2011:

* "Land Rights and Land Administration Training" was provided to 219 PO members.

Staff Development training

Staff development training was a vital part of the organizational capacity building. CDA always placed a special emphasis on staff development training to enable them to better execution of the program and increase the impact among the beneficiary level. CDA availed some of its own staff training from the sources both in country and abroad.

Training organized by CDA for its staff between 2010 and 2011 included:

* Land Rights and Land Administration Training was provided among 25 staff members.

Other capacity building events were attended by CDA staff which were organized and invited by other organizations at the national level.

- * TOT on Land Rights and Land Administration [ALRD].
- * Gender and Education Training Workshop [CAMPE].
- * Environment Management Training [CAMPE].

Access to Public Resources through Peoples Organization (PO)

Dhoula Peoples Organization is situated in Gedura Union in Horipur Upazilla under Thakurgaon District. The village is about 16 kilo meters from Upazilla Parishad. In 1987 we have organised Para based Samilty facilitated by CDA. When there were 4 samities (2 male Samities and 2 Female Samities) in our village we form the village based Peoples Organisation (PO) on 18 may 2003 by incorporating the Samities. After formation of the PO, CDA arranged PO concept internalisation workshop for 40 male and 40 female members. To strengthen the PO and the members CDA provided training on Organisation Development and management. Partnership Development and Management Training, Leadership and Commiunicatin Training, Strategic Planning Training, Project Management Training, Office Management Training, Resource Mobilisational Training, Human Rights and Good Governance Training and the most recent training is Land Rights and Land Administration. After reciving the Land Rights and Land Administration Training On 12 November 2010 in PO General meeting the participants shared their learning among the PO members. According to the decision of the General meeting the PO members identified 73 land less families within the village. Considering the priority the PO members 12 land less families applied for public (khas) land. The PO members also saved 1,33,330 taka by 10 taka every week, by which the provided 19,000 taka loan among 13 PO members. 24,230 taka Invested in Cow rearing project, The cows distributed among other PO members, taken lease of 0.33 acres of land by 22,000 taka and they earned 11,102 taka from this initiative. This year the PO members planted potato 2.50 acres of land where they invested about 43,000 taka and they earned about 25,000 taka. The PO members acknowledged that CDA empowered them by enhancing their knowledge by providing trainings and facilitating supports. They are hopefull to eradicate poverty from their village through the initiation of the Peoples Organsiation (PO).

11. Disabled Development:

According to statistics of the World Health Organization (WHO nearly 16 million people in Bangladesh born disabled in each year. This result is over 10% of our population. These unfortunate people not only have to bear their physical and mental constraints they are also deprived and deprived from their rights.

CDA doesn't have fund to continue such project under Disabled Development but following the trend of group formation and continutation of project achievements under the Women group under Women With Disabilities (WWD) and Disabled Effort for Self Help (DESH) the Groups are functioning with their own efforts to ensure their rights.

During the project period CDA has taken the initiative to building up a regional alliance and network with some like minded

NGOs from the 16 northern districts who are locally act like CDA. Since inception they believe with the people's struggle to the land rights and Agrarian Issues and would like to initiate movement for change of Socio-Political & Ecological condition of the northern part Namely People, land and Agrarian Reform in the Northern Ecological Territory (PLANET). It has already been involved in advocacy activities for the northern peasants and people to reduce the discrimination in terms of investment and development in the north voicing as a regional Forum. Also PLAnet is planning to make it a regional voice to connect with the National and international apex like ALRD, ILC & FIAN / ANGOC/PHM/PAN etc.

CDA operated two nos. of manual husking mills with a daily production capacity of 2,400Kg. The mill operated 365 days per year and employees were involved both permanently and casually:




